Cloud computing is the digital work conducted via network — and cybersecurity is essential for the digitalization of our modern cloud world. Since 2007, initially under the name "antispameurope", Hornetsecurity has been setting the standards in cloud security.

Meanwhile, Hornetsecurity is represented globally by roughly 200 employees in 11 locations, and it protects the email traffic of more than 40,000 customers worldwide. In addition, Hornetsecurity has a growing transnational network of more than 750 sales partners, in the USA, Asia and large parts of Europe. Its services are provided from Hanover via several secure data centers in Germany.

In 2017, the US subsidiary Hornetsecurity Inc. was established in Pittsburgh, Pennsylvania. In June 2018, Hornetsecurity took over the spam filter division of IT security company AVIRA, with more than 3,000 existing customers. This served as an ideal foundation for enhancing its market position and Hornetsecurity expanded into the neighboring countries of Belgium, Netherlands and Luxembourg in July of the same year. In January 2019, Hornetsecurity acquired the Spanish email security company Spamina and thus positioned itself as the leading German cloud security provider for email in Europe. With the takeover of its long-standing distribution partner EveryCloud in January 2020, Hornetsecurity has strengthened its position and significantly increased its presence in the English-speaking market.

Hornetsecurity's product portfolio provides solutions for the overall security of email traffic for companies of all sizes, including multi-level Spam and Malware Protection, fully automated Email Encryption, legally compliant Email Archiving and a Continuity Service, which maintains the email communication and therefore company productivity in the event of a server failure or outage. The Signature and Disclaimer Service ensures a uniform appearance and the inclusion of legally required information in external communication. With Advanced Threat Protection, particularly well planned and targeted attacks such as ransomware and CEO fraud don't stand a chance and all sensitive information stays inside the company, thanks to the Hornetsecurity Spy-Out Forensic System. With 365 Total Protection, Hornetsecurity has launched the industry's only Security & Compliance Suite designed specifically for Microsoft 365. In October 2019, 365 Total Encryption was introduced, which encrypts all content of emails stored in the Microsoft 365 cloud and protects against data theft, unauthorized viewing and spying.

In addition to the reliable protection of email traffic, Hornetsecurity's services are known for their extraordinary user-friendliness, simple administration and a high degree of transparency and control.
